SPECIFIC OBJECTIVES (STRANDS):

EQUALITY, RIGHTS and GENDER EQUALITY STRAND: to promote rights, non-discrimination and equality, including gender equality, and to advance gender mainstreaming and the mainstreaming of non-discrimination (354 MM)

CITIZENS ENGAGEMENT AND PARTICIPATION STRAND: to promote citizens' engagement and participation in the democratic life of the Union and exchanges between citizens of different Member States, and to raise awareness of their common European history (366MM)

DAPHNE STRAND: to fight violence, including gender-based violence (80MM)

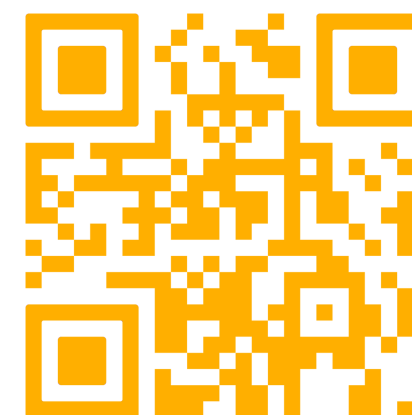
