- Agreeing on milestones, approach and shared understanding what the project wants to achieve and how



Project monitoring

systematic tracking and assessment of project progress and outcomes to ensure that individual projects are effectively contributing to the objectives of the programme

Proactive monitoring: everyday communication, attending events, checking website, etc.

Reactive monitoring: chekcing the reports



Project closure:

- Administrative closure, including the final payment and project closure procedures
- Preparation of Final Report
- Archiving the documents in compliance with programme requirements
- Agreements regarding the durability of project results
- Analysis of project experience and lessons learnt
- Dissemination project results and capitalisation

Legal requirements: Regulation (EU) 2021/1059

(5) Reflecting the importance of tackling climate change in line with the Union's commitments to implement the Paris Agreement adopted under the United Nations Framework Convention on Climate Change and to achieve the United Nations Sustainable Development Goals, the Funds will contribute to mainstream climate actions and to the achievement of an overall target of 30 % of Union budget expenditure supporting climate objectives. In that context the Funds should support activities that respect the climate and environmental standards and that would do no significant harm to environmental objectives within the meaning of Article 17 of Regulation (EU) 2020/852 of the European Parliament and of the Council (7)



CPR: Regulation (EU) 2021/1060

Article 9 Horizontal Principles

- 1. MSs and the Commission shall ensure respect for fundamental rights and compliance with the Charter of Fundamental Rights of the European Union in the implementation of the Funds.
- 2. MSs and the Commission shall ensure that **equality between men and women, gender mainstreaming and the integration of a gender perspective** are taken into account and promoted throughout the preparation, implementation, monitoring, reporting and evaluation of programmes.
- 3. Member States and the Commission shall take appropriate steps to prevent any discrimination based on gender, racial or ethnic origin, religion or belief, disability, age or sexual orientation during the preparation, implementation, monitoring, reporting and evaluation of programmes. In particular, accessibility for persons with disabilities shall be taken into account throughout the preparation and implementation of programmes.
- 4. The objectives of the Funds shall be pursued in line with the objective of promoting **sustainable development** as set out in Article 11 TFEU, taking into account the **UN Sustainable Development Goals, the Paris Agreement and the "do no significant harm" principle.**






