
### **Population of administrative verifications – finding level**

#### Type of finding - Number of Occurrence

MIS Code	Type of error	Number
8.9.1	Expenditure incurred before or after the eligibility period	66
8.9.2	Expenditure not paid by beneficiary	21
8.9.8	Ineligible of expenditure related to double financing	40
8.9.9	Other ineligible of expenditure	34
5.1	Missing supporting information or documentation	33
5.2	Lack or incomplete audit trail	20
7.1	Accounting and calculation errors at project level	32
