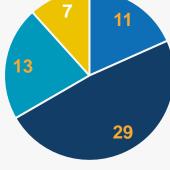

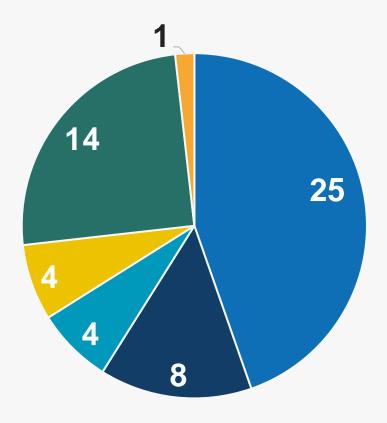

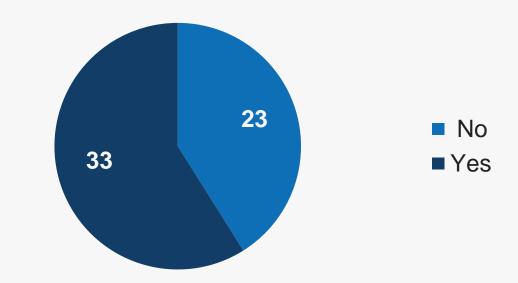

#### Questions from the registration

- ➤ Biggest change between 2014-2020 and 2021-2027
- ➤ Can we use random sampling alongside risked-based sampling in our management verifications?
- ➤ How to identify the risk factors at the first stage of the methodology (does it have to be qualitative or quantitative analysis)? How to identify the riskiest areas in the actual project?
- ➤ Who is responsible (if at all) for checking whether controllers have fully complied with their tasks (checked what was defined in the methodology and not beyond)?



#### Questions from the registration

- ➤ Do the beneficiaries have to know which expenditures will be controlled by the controllers in advance? Does the programme have to communicate its risk-based methodology to the beneficiaries?
- ➤ How to approach sampling in combination with the extensive use of SCOs?
- ➤ What is the approach of the audit authority to the examination of methodologies? What will they focus on? What does the Commission recommend in this area?
- Second-level audits: will they use the same methodology and sample of expenditures, or is it possible that their audit encompasses expenditures not identified as key items and not checked by controllers?
- ➤ How to extend the sample if the errors are identified?
